
**General Instructions:**

2. The candidates will be engaged against different programmes of the Council and duties will be assigned, including field duties, accordingly.
3. Council will also prepare a panel of candidates and offer engagement as and when vacancy(ies) arise during the validity of the panel.
4. The selections will be made for the Institute/Unit/Office as indicated in the advertisement. Once posted, the candidate will not normally be transferred. However, the Council reserves the right to transfer candidates in any other Institute/Units of the Council.
5. The eligibility of the candidates will be determined as on the date of interview.
6. The candidates who fulfill the eligibility requirements may attend the Test/Interview along with an application in the prescribed format (**Annex-I**), Registration Slip duly filled in, along with Original documents and self-attested photocopies of certificates of

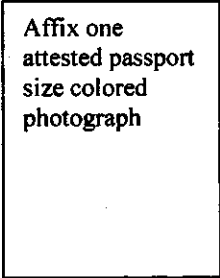
