- 2. The Government of Andhra Pradesh has newly sanctioned the above said posts to Office of the Director General of Prisons and Correctional Services, Andhra Pradesh, Vijayawada, vide G.O Ms. No. 83, Home (Prisons & Fire) Dept. Dated 24-07-2020, with the concurrence of Finance (FMU-H&C) Department, vide their U.O.No.FMU0ASD(HCL)/17/2019, (Computer No.825069), dated. 20.07.2020. This recruitment to the posts mentioned above is being made as per the Rules issued by the Government of Andhra Pradesh in G.O.Ms.No.965, General Administration (SER.B) Department. Dated 21-10-1995, r/w. G.O Ms. No. 485, General Administration (SER.B) Department. Dated 04-08-2018. The recruitment shall be made as per the provisions of the "Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975" and further amendments thereon.
- 3. The Rule of Reservation, requisite educational qualifications, age, physical fitness, procedure to be followed for selection etc., are given below. In addition to that, the requisite certificates (Proformae) to be furnished duly filled in by the candidates are enclosed in the given Annexures. The candidates must read the instructions given in this notification carefully in their own interest.

I) RULE OF RESERVATION:

The rule of Special representation (reservation) provided in Rule 22 of A.P. State and Subordinate Service Rules, 1996 will be applicable to the above said posts, as follows:-

i) **Driver (Light Motor Vehicle)** = 03 Posts = Roster Point 1 (OC) Roster Point 2 (SC) Roster Point 3 (OC)

Note (1): The above said posts of Driver (LMV) in this Head of the Department are excluded from the local cadres and from the scheme of localization in terms of "Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975" and further amendments thereon.

Note (2): As there are no eligible candidates to fill up by promotion as Driver (HMV) in this office, the above said posts of Driver (HMV) are hereby notified through Direct Recruitment as per A.P. General Subordinate Service Rules, 1995. These posts are excluded from the local cadres and from the scheme of localization in terms of "Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975" and further amendments thereon.

Note (3): Religion and Community certificate in Original shall be submitted along with application, if the candidate claims reservation by virtue of belonging to any community. The certificate must have been issued by the competent revenue authority not below the rank of Mandal Revenue Officer or equivalent.

II) AGE LIMIT (AS ON 01-07-2020) FOR DRIVER (LMV & HMV):-

- i) Minimum Age: Not less than 18 Years.
- ii) Maximum Age: 34 Years

The upper age limit prescribed in Para (a) above will be relaxable as under;

- a) Up to a maximum of five years, if a candidate belongs to a Backward Class or a Scheduled Caste or a Scheduled Tribe.
- b) Length of regular service limited up to a maximum of five years if a candidate is an employee of A.P. State Government (Employees of APTRANSCO, Discoms, APGENCO, APSRTC, Corporations, Municipalities, Local bodies etc. are not entitled for age relaxation).
- c) Three years in addition to the length of service rendered as a whole time Cadet Corps Instructor in NCC provided the candidate rendered a minimum service of 6 months as a whole time Cadet Corps Instructor in NCC and he has been released from NCC.
- d) Up to a maximum of three years, if a candidate is a retrenched temporary employee in the State Census Department with a minimum service of 6 months during 1991

Save as provided above, the age limits prescribed can in no case be relaxed.

NOTE: The date of birth will be accepted as per their School Certificate (or) Secondary School Certificate (or) Matriculation or an equivalent examination certificate (or) equivalent certificate recognized by the State Government in support of the date of birth. If the above certificates are not available with them, then only the birth certificate in Original with Date of Birth issued by the Municipal Corporation (or) service records will be accepted.

III) EDUCATIONAL QUALIFICATIONS FOR DRIVER (LMV & HMV):-

- i) The candidate, as on 1st July, 2020, must be able to read and write Telugu and Urdu or English for both the Driver (LMV) and Driver (HMV) posts.
- ii) For Driver (LMV), one must possess a current valid Light Motor Vehicle Driving license issued by the competent authority, under the motor vehicle act 1988 with practical experience of driving Motor Vehicle for a period of not less than 3 years with endorsement to drive motor Cycle and Auto richsahw.
- iii) For Driver (HMV), one must possess a current valid Driving license of Motor Vehicle issued by the competent authority under the motor vehicle act 1988 to drive a heavy motor transpost vehicle, with practical experience of driving Motor Vehicle for not less than 3 years.

IV) PHYSICAL STANDARDS FOR DRIVER (LMV & HMV):-

The candidates shall obviously submit an Original certificate of their Physical, Medical and Health Standards on the following, from not below the rank of Civil Surgeon from the Government Hospitals (or) recognized Hospitals in Andhra Pradesh.

- ii) Each eye must have a full field of vision. Colour blindness, squint or any morbid condition of the eye or lids of either eye shall be deemed to be a disqualification.
- iii) The candidate should possess sound health and be free from any bodily defect or infirmity which will render him unfit for the said posts.

- iv) Candidates who have the following ailments or defects will not be considered for recruitment to the above said posts.
 - a) Physically handicapped
 - b) Knocking-knees, pigeon chest, flat foot, Varicose veins, Hammer toes, fractured limbs, decayed teeth, stammering, hard of hearing and abnormal psychological behaviour.

NOTE: In order to prevent disappointment, candidates are advised to have themselves examined by a Civil Surgeon before applying for the above said posts to ensure that they meet the prescribed Physical and Medical Standard.

V) PROCEDURE FOR OBTAINING AND SUBMITTING THE APPLICATION FORM FOR DRIVER (LMV & HMV):-

- i) Candidates must get the application form, from the Office of the Director General of Prisons and Correctional Services, A.P, Vijayawada against cash payment of Rs. 100/- (Rupees One hundred only) (including tax) between 10.00 A.M. to 5.30 P.M. from 04-01-2021 to 11-01-2021 on all working days (Monday to Friday).
- ii) Application forms can be purchased from this office by anyone other than the candidate also. There will be no restriction on the number of applications sold to each individual.
- iii) Eligible candidates should submit the application form (duly filled in) along with the copies of the necessary certificates in a sealed cover addressed to the Director General of Prisons and Correctional Services, A.P, Durgapuram, Vijayawada-520003, on or before 11-01-2021 in between 10.00 A.M. to 5.30 P.M on all working days (Monday to Friday).
- iv) Separate application along with supporting documents shall be submitted to each category of post by a candidate.
- v) The filled in applications shall reach to this office on or before the above said due date in person or by Registered post with Acknowledgement due or through their nominee and obtain acknowledgement from office of the Director General of Prisons and Correctional Services, A.P, Vijayawada and should produce the acknowledgement at the time of appearing for the verification of Physical standards and selection.
- vi) Applications submitted after 5.30 P.M. on 11-01-2021 will not be accepted. Incomplete applications or applications without prescribed enclosures will not be entertained.

- vii) The candidates applying for the above posts should ensure that they fulfill all eligibility conditions. Their admission at all the stages of the examination will be purely provisional and subject to satisfying the prescribed eligibility conditions.
- viii) Mere submission of the application by the candidate will not imply that his candidature has been finally cleared by the Department.
- ix) The Director General of Prisons and Correctional Services, A.P., Vijayawada will be the Chairman for this Notification and take up verification of eligibility conditions with reference to original documents only after the candidate has provisionally qualified.

VI) PROVISIONAL SELECTION PROCEDURE / SCHEME FOR DRIVER (LMV & HMV): -

The provisional selection procedure/scheme of the exam will be as follows for the posts of Driver (LMV & HMV):

- PHYSICAL FITNESS TEST: The Chairman of the Selection Committee will scrutinize the applications received from the candidates. Basing on the correctness and genuinity of the certificates furnished by the candidates along with the application, the eligible candidates will be intimated to appear for the Physical Fitness Test on a prescribed date, at the Office of the Director General of Prisons and Correctional Services, Durgapuram, Vijayawada. The candidates, who found fit physically for the posts of Drivers (LMV & HMV) in presence of the members of the Committee constituted, will be eligible to appear for Driving Test.
- ii) DRIVING TEST: The candidates who possessed physical fitness and minimum physical standards will be required to appear for a Driving Test to be held at Municipal Stadium, Vijayawada on the prescribed date to be informed or subsequent dates also depending on the number of candidates after verification of their Physical standards. Candidates should make their own arrangements for their transportation, boarding, stay etc., during the selection process. Selection Committee will not entertain any representations of the candidates who fails to attend the Selection Process.

The candidates must qualify in the Driving Test carrying a maximum of 100 marks in (8) parameters mentioned below out of which at least (50) marks must be obtained.

If a candidate secures less than the prescribed minimum marks in (3) or more of the following parameters, he should be deemed to have failed in the test, even though he secures pass marks in the aggregate.

VII) RESERVATION TO LOCAL CANDIDATES OF ANDHRA PRADESH FOR THE POSTS OF DRIVER (LMV & HMV):

The above said posts of Driver (LMV & HMV) in this Head of the Department are excluded from the local cadres and from the scheme of localization in terms of "Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975" and further amendments thereon. Hence, these posts are State wide.

According to Order of President of India, G.S.R.1350(E), dated: the 30th October, 2017 published in the Gazette of India, Extraordinary, Part-II, Section-3, Sub-Section (i), in the Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975, candidates who migrate to any part of the State of Andhra Pradesh from the State of Telangana within a period of five years from the 2nd day of June, 2014 shall be regarded as the local candidate in the State of Andhra Pradesh at the place of his residence and be treated at par with the local candidates residing in that area, in accordance with such guidelines as may be issued by the Government of Andhra Pradesh for the purpose of employment.

Modalities for the same are given by the Government of Andhra Pradesh vide Circular Memo.No.4136/SPF&MC/2015-13 dated 20-11-2017. Candidates who are covered by this order will be required to submit necessary certificate as per the instructions given by the Government of Andhra Pradesh at the time of submission of application form, as detailed in Annexure-II.

<u>PREFERENCE:</u> When two or more candidates in a particular category obtain equal marks on merit, preference will be given to the candidate, who was born earlier.

VIII) FINAL SELECTION FOR DRIVER (LMV & HMV):

- i) No preference will be given to the candidates of Andhra Pradesh, as Local & Non-Local. The final selection of these posts will be based on the <u>combined merit list</u> of the candidates in the entire selection process.
- ii) Final selection will be strictly on relative merit of the candidates in each category of the above said posts, as obtained by them based on their score in the Driving Test and as per the provisions of "The Andhra Pradesh Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975" and G.O. (P). No. 763, General Administration (SPF.A) Dept., dated 15-11-1975 as amended from time to time.
- iii) The selection of the candidates will be provisional and subject to verification of all the required original certificates, physical fitness, medical fitness certificate and antecedents.
- iv) No person shall be eligible for appointment to any service by direct recruitment unless he satisfies the selection authority as well as the appointing authority that his character and antecedents are such as to qualify him for such service.
- v) Suppression of material facts or withholding any factual information in the attestation form (which would be supplied to the candidates who will be provisionally selected) will disqualify the candidate from being considered for appointment. In the event of any information being found false or incorrect or ineligibility being detected at any time even after appointment, he will be discharged from service forthwith by the appointing authority without giving any notice.
- relevant documents (or) attend medical examination (or) join the training/Service: The candidates who are provisionally selected for any one of the post specified in this notification will be asked to submit an attestation form, produce other relevant documents and attend medical examination on a specified date. The candidates who become eligible to be sent for training will be asked to join the training on a specified date. If any candidate fails to respond and fails to submit the necessary form or document or attend the medical examination or join the training on a specified date, his / her provisional selection may be cancelled without prior notice to the candidate

IX) TIME SCALE OF PAY:

i) On successful completion of final selection process to the above said posts i.e. Driver (LMV & HMV), subject to verification of the original certificates, antecedents and medical examination, the candidates so selected to the said posts will be appointed in the Government services on regular basis in the newly sanctioned posts, in the Office of the Director General of Prisons and Correctional Services, Andhra Pradesh, Vijayawada, in the following time scale of pay, under Revised Pay Scales, 2015.

a) Driver (LMV) : TS: Rs. 15460-47330 (RPS-2015) b) Driver (HMV) : TS: Rs. 17890-53950 (RPS-2015)

ii) The employees who are appointed on or after 01-09-2004 are covered by the Contributory Pension Scheme. The existing Pension Scheme as per A.P. Revised Pension Rules, 1980 will not be applicable to them.
