# PARA - III: ACADEMIC QUALILFICATIONS

### PARA IV: METHOD OF SELECTION

- a) As per merit on the basis of marks secured in S.S.C examinations
- b) If two or more candidates are found to have same percentage of marks, person having higher age will be given 1<sup>st</sup> rank among the candidates
- c) In case of further tie, marks secured in the Science subject in SSC will be considered.
- 'd) Candidates who applied with higher qualifications will be considered as per SSC only.

### PARA V: AGE LIMIT

The minimum and maximum age shall be reckoned as on 01.07.2020 with relaxations allowed by the government. The candidates should complete (18) years and should not have completed 42 year of age as on 01.07.2020.

- a) For SC's /ST's and BC's relaxation will be for (05) years.
- b) For Ex-Servicemen relaxation will be for (03) years.
- c) For Physically Challenged Persons (10) years.
- d) If a candidate is eligible under more than one category of relaxation, exception will be given under only one category in which he /she is selected.

# PARA VI: APPLICATION PROCESS FEE

Each applicant must pay application process fee of Rs.100/- (Rupees One hundred only) by the way of online transfer using the payment option mode available in the website.

# PARA VII (A): RULE RESERVATION

The Rule of Special Representation (General Rule 22 & 22A) shall apply to appointments by direct recruitment to various posts in service. Reservation for Physically Handicapped persons in respect of posts of Lab Attendants, shall be made, provided they fulfill the following:-

- a. Both the eyes of the candidates shall not be blind.
- b. In case of visually handicapped category, one eye shall be perfectly working and the candidate shall otherwise be physically fit.
- c. In case of 2<sup>nd</sup> category i.e., Hearing Handicapped, the defect shall be less than 50%.
- d. In the orthopedically handicapped category, the defect shall be minimum and the selection committee satisfies that the selected candidate can perform his duties without any difficulty.

# PARA VII (B):RULE OF RESERVATION TO LOCAL CANDIDATES

The Rule of reservation to Local candidate is applicable as per A.P. Public Employment (Organization of local cadres) and regularization of Director Recruitment order 1975 (G.O.Ms.No. 674; G.A.(SPF.A) Dept DT:29-10-1975) G.O.PNo.763;G.A.(SPF.A) Dept, dt:15/11/1975), read with G.O.Ms.No.124, G.A.(SPF.A) Dept, Dt; 7/3/2002.

# a) i) LOCAL STATUS FOR THE PRESENT POSTS:

b) Reservation to the local candidates is applicable as provided in the Rules and as amended from time to time as in force on the date of notification. The candidates claiming reservation as local candidates should enclose the required study certificates (from IV class to SSC) or Residence Certificate as the case may be. Subsequent production of the certificates will not be entertained under any circumstances.

### c) Definition of local candidate:

i. "Local Candidate" means a candidate for selection to any a post in relation to that Local area where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she appeared for SSC or its equivalent examination. If however, he/she has not studied in any educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period.

- ii. In case the candidate does not fall within the scope of the above, it will be considered if he/she has studied for a period of not less than seven years prior to and inclusive of the year in which he/she has studied for the maximum period out of the said period of seven years and where the period of his/her study in two or more local areas are equal such local area where he/she has studied last (in such local areas) will be taken for determination the local candidature. Similarly, if he/she has not studied during the above said period in any Educational Institution(s) the place of residence during the above period will be taken into consideration and local candidature determined with reference to the maximum period of residence or in the case of equal period where he/she resided last.
  - iii. If the claim for local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution(s) where he/she has studied during the said 4/7 years period. If, however, it is based on residence, a certificate should be submitted which is obtained from an Officer of the Revenue Department not below the rank of Tahasildar, in independent charge of a Mandal.
- d) Residence certificate will not be accepted, if a candidate has studied in any Educational institutions up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.
- e) The candidates claiming reservation as Local candidates should enclose the required certificates issued by the concerned authorities. Subsequent production of the certificate will NOT be entertained under any circumstances.

- 3. The candidates should reside at their place of posting only.
