If no disabled persons are available, the posts will be filled with General women candidates as per G.O MS No : 99 Dated 4-3-2013 of Govt. of A.P

## PARA – II: SELECTION PROCESS

The selection of candidates shall be made by the Registrar, Sri Venkateswara Veterinary University, Tirupati as per the Government order vide G.O.Rt.No.23, AH, DD & F (AH.II) Dept, Dt: 03.02.2021 and Certificates verification shall be done by the concerned District Joint Directors(AH).

## PARA – III: ACADEMIC AND TECHNICAL QUALIFICATIONS

The candidate should have valid registration with AP Para Medical Board

## PARA – IV: METHOD OF SELECTION

- As per merit on the basis of marks in Diploma in Medical Laboratory Technology (DMLT) Course.
- If two or more candidates are found to have same percentage of marks, person having higher age will be given 1<sup>st</sup> rank among the candidates.
- However incase of further tie, candidate having merit in S.S.C will be given preference

## PARA – V: AGE LIMIT

The minimum and maximum age shall be reckoned as on 01.07.2021 with relaxations allowed by the government. The candidates should complete (18) years and should not have completed 42 year of age as on 01.07.2021.

- For SC's /ST's and BC's relaxation will be for (05) years.
- For Ex-Servicemen relaxation will be for (03) years.
- For Physically Challenged Persons (10) years.
- If a candidate is eligible under more than one category of relaxation, exception will be given under only one category in which he /she is selected.

**PARA – VI: APPLICATION PROCESS FEE**

Each applicant must pay application process fee of Rs.200/- (Rupees Two hundred only) by the way of online transfer using the payment option mode available in the website.

**PARA – VII (A): RULE RESERVATION**

The Rule of Special Representation (General Rule 22 & 22A) shall apply to appointments by direct recruitment to various posts in service. Reservation for Physically Handicapped persons in respect of posts of Lab technicians shall be made, provided they fulfill the following:-

- a. Bothe the eyes of the candidates shall not be blind.
- b. In case of visually handicapped category, one eye shall be perfectly working and the candidate shall otherwise be physically fit. Per cent of disability shall be minimum of 40% and less than 50%
- c. In case of 2<sup>nd</sup> category i.e., Hearing Handicapped, the defect shall be minimum of 40 % and less than 50%.
- d. In the orthopedically handicapped category, the defect shall be minimum of 40% and the appointing authority satisfies that the selected candidate can perform his duties without any difficulty.

**PARA – VII (B): RULE OF RESERVATION TO LOCAL CANDIDATES**

- a) The Rule of reservation to Local candidate is applicable as per A.P. Public Employment (Organization of local cadres) and regularization of Director Recruitment order 1975 (G.O.Ms.No. 674; G.A.(SPF.A) Department, Dated:29-10-1975) G.O.No.763;G.A.(SPF.A) Department Dated:15/11/1975), read with G.O.Ms.No.124, G.A.(SPF.A) Dept, Dated; 7/3/2002.

a) i) **LOCAL STATUS FOR THE PRESENT POSTS:**

b) Reservation to the local candidates is applicable as provided in the Rules and as amended from time to time as in force on the date of notification. The candidates claiming reservation as local candidates should enclose the required study certificates (from IV class to SSC) or Residence Certificate as the case may be. Subsequent production of the certificates will not be entertained under any circumstances.

c) **Definition of local candidate:**

- i. "Local Candidate" means a candidate for selection to any a post in relation to that Local area where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she appeared for SSC or its equivalent examination. If however, he/she has not studied in any educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period.
- ii. In case the candidate does not fall within the scope of the above, it will be considered if he/she has studied for a period of not less than seven years prior to and inclusive of the year in which he/she has studied for the maximum period out of the said period of seven years

and where the period of his/her study in two or more local areas are equal such local area where he/she has studied last (in such local areas) will be taken for determination the local candidature. Similarly, if he/she has not studied during the above said period in any Educational Institution(s) the place of residence during the above period will be taken into consideration and local candidature determined with reference to the maximum period of residence or in the case of equal period where he/she resided last.

iii. If the claim for local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution(s) where he/she has studied during the said 4/7 years period. If, however, it is based on residence, a certificate should be submitted which is obtained from an Officer of the Revenue Department not below the rank of Tahasildar, in independent charge of a Mandal.

d) Residence certificate will not be accepted, if a candidate has studied in any Educational institutions up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.

e) The candidates claiming reservation as Local candidates should enclose the required certificates issued by the concerned authorities. Subsequent production of the certificate will NOT be entertained under any circumstances.

#### **PARA – VIII: HOW TO APPLY**

The candidates should upload the application in the website [www.svvu.edu.in](http://www.svvu.edu.in) and upload the all relevant enclosures through online on or before 3-8-2021, 5.0 P.M. **But the candidates have to complete their Registration and Payment on or before 1-8-2021, 5.0 PM.**

**PARA – IX: INSTRUCTIONS TO THE CANDIDATES**

1. The appointments are purely temporary and on contract basis as mentioned.
2. The candidates should work in any place in the District according to the need of the department.
3. The candidates should reside at their bonafied head quarters.

**PARA – X: ENCLOSURES**

1. Mark memos and original certificate of DMLT
2. SSC or equivalent certificate for evidence of Date of Birth.
3. Latest Caste Certificate issued by the Tahsildar concerned.
4. Study certificates from 4th class to 10<sup>th</sup> class issued by the concerned school authorities or residence certificate for seven year preceding to SSC in case of private study
5. Certificate of Registration with AP Paramedical Board.
6. Physically Handicapped certificate (SADARAM) in respect of candidates claiming reservation under P.H quota.

Applications submitted without required particulars and incomplete applications will summarily be rejected.

Candidates are informed that the recruitment process will be done by the Sri Venkateswara Veterinary University, Tirupati transparently according to merit and rule of reservation etc. Hence, candidates are advised not to resort for any unethical practices and cooperate with the Selection process for transparent selection of candidates.
