**RECRUITMENT NOTICE**

**RECRUITMENT FOR THE POST OF SENIOR RESIDENT  
(NON ACADEMIC) AT AIIMS, BIBINAGAR**

1. Consequence upon the Govt. of India Ministry of Health & Family Welfare letter No A-11013/2/2019-PMSSY-IV-Part(1) (EO.8082044) dated 19<sup>th</sup> September 2021. All India Institute of Medical Sciences, Bibinagar invites application for the post of Senior Resident (Non Academic) at AIIMS, Bibinagar under Govt. of India, Residency Scheme 1992.
2. Details of vacancies for the post of Senior Residents are as under :-

4. The application form will be available on AIIMS, Bibinagar official website.

5. **Essential Qualifications:-**

- A Postgraduate Medical degree viz. MD/ MS/ DM/ M.Ch/ DNB in their respective disciplines recognized by MCI /Institute of National Importance.
- Candidates having MD/DNB in Emergency Medicine can apply for the post of Senior Resident in the department of General Medicine/ Anaesthesia.
- Only those candidates who have been declared passed in the Post-Graduate degree i.e MD/MS/ DNB (as applicable) will be eligible to be considered for the vacant post as notified in that quarter.
- However, in case of those who have appeared for exam. / viva voce and result are yet to be declared then applicant will be allowed in interview provisionally. In such cases, a bonafide certificate duly signed by the Head of the Institute / Competent authority regarding continuation of the course and probable date of completion of tenure may be produced.

**In cases, where pass certificate of qualifying exam is not submitted at the time of joining, the candidature of such selected candidates will stand cancelled and no claim for Joining on the basis of selection will be entertained.**

6. **Application Process:**

- Candidates who are fulfilling the eligibility criteria may wish to participate in interview have to fill the application form which will be available at [www.aiimsbibinagar.edu.in](http://www.aiimsbibinagar.edu.in). Candidates may send the duly filled application form with receipt of application fee through to this Email i.e. [ace.aiimsbbnagar@gmail.com](mailto:ace.aiimsbbnagar@gmail.com).
- The original certificates of qualifying degrees i.e. MBBS degree certificate, Internship Completion Certificate, MD/ MS/ DNB, Registration Certificate, Date of Birth Certificate, Caste Certificate and other relevant certificates etc. of the candidates who are selected for the post of Senior Residents, will be verified.
- If any candidate, who joins the post and leaves/resigns/gets terminated before the completion of the tenure, he/she may do so by giving one month's prior notice as per the rules or by depositing pay and allowance in lieu thereof with the Institute for the period of which notice falls short of one month or so.

7. **Tenure.** The appointments for the posts of Senior Residents shall be for a maximum period of 03 years as per the Residency Scheme 1992, Govt. of India.

8. **Application Fees:-**

- General/OBC Category : Rs.1500/-with transaction Charges as applicable.
- SC/ST/EWS Category : Rs.1200/-with transaction Charges as applicable.

- The candidate must produce the receipt of requisite application fee at the time of interview without fail.



9. **UPPER AGE LIMIT:-**

- For eligibility to apply for the posts of Senior Resident, upper age limit will be 45 years as on the last date of submission of application. This is relaxable for OBC candidates upto a maximum period of 03 years and SC/ST candidates upto a maximum period of 05 years.
- In case of PWBD candidates, age relaxation is upto maximum period of 10 years for General Category, 13 years for OBC category and 15 years for SC/ST category candidates.

10. **RESERVATION:-**

- The reservation for EWS/OBC/SC/ST candidates is as per Central Govt. rules and 4 % for PWD candidates (on horizontal basis).
- For OBC Candidate: Candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application.
- For EWS, OBC, SC and ST - Certificate should be issued by Tehsildar or above rank authorities prescribed by Govt. of India in format of State/Central Government.

• **For Persons with Disability (PWD):**

- The candidate must possess a valid document certifying his/her physical disability is conforming to judgment of Supreme Court of India i.e.: "With the approval of the Ministry of Health & Family Welfare, Govt. of India vide letter no. 18018/2/2009-ME(P-1) dated 17.02.2009 it has been decided that while providing reservation in admission to medical course in the first instance candidates with disability of lower limbs between 50% to 70% shall be considered and in case candidates are not available of such candidates in that category then the candidates with disability of lower limbs between 40% to 50% will also be considered for admission as per decision in the Writ Petition (Civil) 184/2005- Dr. Kumar Sourav Vs. UOI & others in the Supreme Court of India".
- The disability certificate should be signed by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/ Institutions & countersigned by Medical Superintendent.
- The constitution of the Medical Board will be one consultant each from disciplines of Orthopaedics, Physical Medicine & Rehabilitation and Surgery.
- PWD candidates who apply will be considered against seats in category in which he/she has applied i.e. GEN/EWS/OBC/SC/ST. Last seat/s in the respective category will be offered to PWD candidates, in case PWD candidate is not able to make on his/her their own merit.

• **For EWS (Economically Weaker Sections):**

- 10% of Vacancies are reserved for the EWS as per the directions of Government of India instructions issued vide DoPT OM No. 36039/1/2019-Estt (Res) dated 19<sup>th</sup> January 2019.

- Persons who are not covered under the existing scheme of reservations to the Scheduled Castes, the Schedule Tribes and the socially and Educationally Backward Classes and whose family has gross annual income below Rs. 8.00 lakh are to be identified as EWSs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the Following assets shall be excluded from being identified as EWSs, irrespective of the family income:

- 5 acres of Agricultural Land and above;
- Residential flat of 1000 sq. ft. and above;
- Residential plot of 100 sq. yards and above in notified municipalities;
- Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

- The income and assets of the families as mentioned in Para 2 would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs. The candidates shortlisted for document verification/ interview shall be required to bring the requisite certificate as specified by the Government of India at the time of appearing for the process of document verification/interview. The income and asset certificate issued by one of the authorities mentioned shall only be accepted as proof of candidate's claim as belonging to EWS.

- The instructions issued by the Government of India in this regard from time to time shall be adhered to.

- Date of issue of Certificate should not be earlier than 1 year from the last date of submission of Application Form for Junior Residency.

11. **Selection Procedure :-**

- Written examination may be conducted when number of applicants are more than three times than the number of posts advertised. However, there will be no written test for the post against which less number of applications are received than the vacancies. Director, AIIMS, Bibinagar shall have the discretion to decide for which post, written examination to be conducted and for which post there will be no written examination and his decision will be final.




- The merit list (selected and waiting list) for all categories i.e UR/EWS/ OBC / SC / ST shall be prepared on the basis of combined marks of written test and personal interview or only Personal Interview.
- Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit panel. All applicants must provide latest mobile numbers and e-mail for timely communication.
- For qualification /Reservation / Selection Procedure/Emolument/date of Interview and other latest details, candidates are advised to visit AIIMS, Bibinagar website regularly.
- Selected Candidate will be expected to stay in Institute Campus if offered residential accommodation.

12. **Terms & Conditions:-**

- Canvassing information of any kind will lead to disqualification. Incomplete applications will not be considered and will be REJECTED. No interim correspondence shall be entertained.
- The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
- The appointees shall be granted leave in accordance with the instructions issued by the Government of India from time to time.
- Private practice of any type is strictly prohibited
- He / She may work in shifts and can be posted at any place in the Institute as per the discretion of the MS/Dean/Director.
- He/ She is expected to abide by the rules of conduct and discipline as applicable to the Institute employees.
- The candidate should not have been convicted by any Court of Law.
- In case, any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any information relevant to this appointment, he/she will be liable to be removed from the service *and* action will be taken as deemed fit by the Competent Authority.
- The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- All disputes will be subject to jurisdictions of High Court, Hyderabad (Telangana).
- Candidates working in Govt. / Semi-Govt. PSU should apply through proper channel. The candidates in-service will not be permitted for examination / interview, without "No Objection Certificate" from the employer. In this connection, it is mentioned that as per the terms and conditions of Central Residency Scheme, their engagement is to be regulated as per the CCS (Temporary Service Rules).

On selection, the candidates will be given one month time to join the post at AIIMS, Bibinagar. In exceptional situations (with reasonable justification) extension may be granted by the Competent Authority.

- The post will be on tenure engagement for a period of maximum 03 (three) years including such engagement earlier if any (if you have already served as Senior Resident in previous appointment, the same will be calculated along with the present engagement at AIIMS, Bibinagar). However, the performance will be reviewed by a committee duly constituted by the Director on completion of 01 year tenure on every occasion and further extension beyond 1<sup>st</sup> year or 2<sup>nd</sup> year will be based on the recommendations of the said review committee. In case the performance is not satisfactory, then further extension will not be considered.
- The Competent Authority reserves the right to cancel the advertisement at any point of time without assigning any reason there of or fill up less/more number of posts as advertised depending upon the Institutional requirement.
