Recruitment Notification for filling up of unfilled Roster Points and Resigned posts of Lab Technician Gr-II, Optometrist, Dental Hygienist, Radiation Safety Officer, Bio-Medical Engineer, Speech Therapist, Attender, Packer (Laundry) to work in Govt. General Hospital, SPSR Nellore on Contract/ Outsourcing (APCOS) basis.

**Instructions to the Candidates:**

**PARA-1:**

As per the orders of the Principal Secretary to Government, HM&FW Department vide Rc.No.2346/CHFW/2022 Dated 05-05-2022 of the Commissioner of Health and Family Welfare AP Vijayawada, applications are invited from the qualified and eligible candidates with effect from 24-07-2022 to 30-07-2022 (by 05:00 PM) for the recruitment of Paramedical & other Category of posts sanctioned for the Govt. General Hospital, Nellore on Contract/ Outsourcing basis through the District Selection Committee (DSC), SPSR Nellore District.

**NOTE:** The candidates are instructed to go through the guidelines issued in the notification and advised to apply accordingly. The number of vacancies is provisional and likely to increase or decrease as per the need of the department and subject to the legal provisions governing the recruitment process.

**PARA-2: AGE: (As per G.O.Ms.No.105 G.A.(Ser-A) Dept, dated 27-09-2021)**

No person shall be eligible if he/ she is less than 18 years of age and if he/ she is more than 42 years of age as on 01-07-2022. Candidates should not be born earlier than 02-07-1980 and not later than 01-07-2022.

**Age Relaxation is applicable to the categories as detailed below:**

- i) For S.C. S.T. & B.C.s 5 (Five years).
- ii) For ex-service Men 3 (Three) years in addition to the length of service in armed forces.
- iii) For Physically Challenged persons 10 (Ten) years.

**PARA-3: FEE:**

Each applicant must pay application process fees of Rs. 500/- (Rupees Five hundred only) (For OC) & Rs.300/- (Rupees Three hundred only)(For BC/SC/ST&Others) to be paid in favour of the Account No: **250301000915** of ICICI Bank, Vedayapalem Branch, Nellore, IFSC Code: **ICIC0002503**.

**Mode of Payment: through on-line/ UPI/ Bank and UTR/ Receipt/ Counterfoil should be enclosed/ mention with the application.**

**PARA-4: RESERVATIONS (R.O.R.):**

- a) There will be reservations to the candidates in respect of Scheduled Tribes (ST), Scheduled Castes (SC), Backward Classes (BC), Economically Weaker sections (EWS), Physically Challenged (VH, HH, OH, MI) Women, Ex-servicemen and Meritorious Sports Persons as per Rule 22 (A) of AP State and Subordinate Services Rules 1996.
- b) Caste & Community, Community certificate issued by the Competent authority in terms of GO.Ms.No.58 SW(J) Dept. date 12.05.1997 should be submitted appropriate time. As per AP State and Subordinate services Rules, Rule 2(28) Explanation: In so far as claiming for SC reservation is concerned, no person who professes a religion different from Hinduism shall be deemed a member of Scheduled Caste. However, Scheduled caste. BCs, SCs, STs & EWS belonging to other state or not entitled for reservation.
- c) There shall be reservation to Women horizontally to an extent of 33 1/3% in terms of rule 22(A) of AP State and Subordinate Service Rules as per G.O.Ms.No.63 GA(Ser-D) Dept. date 17.04.2028.
- d) Reservation to BC-E group will be subject to the adjudication of litigation before the Hon'ble Courts including final orders in Civil Appeal no. (a) 2628-2637 of 2010 in SLP no.7388-7397 of 2010 dt.25.03.2010 and order from the Government.
- e) Economically Weaker Sections (EWS) means the persons who are not covered under existing scheme of reservations for SCs, STs, Socially and Economically Backward Classes and whose gross annual family income is below Rs.8.00 lack or identified as Economically Weaker Sections (EWS) for the benefit of the reservations. The income shall also include income from all sources i.e., Salary, Agriculture, Business, Profession, etc., for the financial year prior to the year of application. The persons seeking the benefit of reservations under EWS category shall obtained the necessary EWS certificates issued by the Tahsildar concerned and produce at an appropriate as per G.O.Ms.No.73 GA(Ser-D) Dept. dt 04.08.2021.

**Reservation to Local Candidates:** Reservation to the Local Candidates is applicable as provided in Article 371-D as per GO.Ms.No.674 GA(SPF-A) Dept date 20.10.1975 and rules amendment from time to time and as in force on the date of notification. The candidate claiming as local candidates should obtain the required study certificates (from 4<sup>th</sup> class to 10<sup>th</sup> class or SSC) or Residence certificate in the proforma prescribed for those candidates who have not studied in any education institutions as the case may be.

**PARA-5: SELECTION CRITERIA:**

In terms of the GO.Rt.No.301 HM&FW (D1) Dept. Dated 20.06.2020 and GO.Rt.No.211 HM&FW(D2) Dept. dated 08.05.2021 the selection procedure for the post of para medical and other posts as mentioned below:

**NOTE:** If the candidate desires to apply for more than one post - Separate application must be submitted for each post.

#### **PARA-7: INSTRUCTIONS TO CANDIDATES:**

The above Contract/ Outsourcing appointments are purely on temporary initially for period one year and can be terminated at any time without assigning any reasons.

#### **PARA-8: DEBARMENT:**

Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all respects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for these recruitment & future recruitments.

**PARA-9: DEPARTMENT/ DSC DECISION TO BE FINAL:**

The decision of the department pertaining to the application and its acceptance or rejection as the case may be conduct of counselling and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned under the powers vested with it. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

9	Physically Handicapped certificate (SADAREM certificate vide G.O.Ms.No.35 HM&FW(A) Department, dated.10-04-2018) in case of candidates claiming reservation under PH quota.
10	Relevant certificate in respect of candidates claiming Ex-Servicemen/ Sports quota.
11	The candidates who have rendered services on contract/ Outsourcing basis under earmarked Govt., Institutions/ State and Central Govt., Schemes in the State of Andhra Pradesh/ COVID-19 Duties should enclose Service certificate duly signed by competent authority.

**Note:** Application submitted without the required certificates and in complete filled application will be rejected summarily.
