- 5) Vigilance/Administrative clearance of the concerned Port in the prescribed proforma as per Ministry's letter No.A12022/10/205-PE-I, dt.27.08.2010, duly filled in all respects.
- 6) Two latest passport size photographs (to insert/attach in an envelope).
- 7) The crucial date to determine the eligibility criteria for 03 (three) posts is 01.07.2022 and for one anticipated vacancy is 01.09.2022.
- 8) Undertaking of the applicants to the effect that candidature will not be withdrawn, if selected.
- 9) Incomplete application or application received after the due date will not be considered.
- 10) The last date for receipt of application duly completed, by the Port Authority is 29.07.2022. Incomplete application or application received after the due date will not be considered.
