I. ELIGIBILITY OF CANDIDATES:

(G.O.Ms.No.88 Law (LA & J-Home Courts-c) Dept. Dt. 05.08.2011)

Retired employees of Andhra Pradesh Judicial Ministerial Services or retired employees of the corresponding categories of Andhra Pradesh High Court Service, and in the event of non-availability of eligible and suitable retired employees from Andhra Pradesh Judicial Ministerial Services and Andhra Pradesh High Court Services, the District and Sessions Judges can recruit the eligible candidates directly on contract basis

II. QUALIFICATIONS PRESCRIBED FOR THE RETIRED EMPLOYEES:

(Hon'ble High Court of A.P. at Hyderabad in ROC.No.701/E1/2010 dt. 23.04.2011)

Age: For Retired Judicial employees: (Hon'ble High Court's ROC.No.701/E1/2010 dt. 1.08.2011)

The upper age limit of the retired employees to work in the Special Magistrate Courts on contract basis is Seventy (70) years .

HEAD CLERK

- 1 Ministerial Officers who retired as Head Clerk and above
- Ministerial Officers who retired on attaining the age of superannuation and who have not attained the age of sixty nine years.
- 3. Ministerial Officers having satisfactory record of service
- Persons who have received any punishment for any misconduct in disciplinary proceedings while in service are not eligible for consideration

JUNIOR ASSISTANT

- 1. Ministerial Officers who retired as Junior Assistants or Senior Assistants
- Ministerial Officers who retired on attaining the age of Superannuation and who
 have not attained the age of sixty nine years.
- 3. Ministerial Officers having satisfactory record of service
- 4. Persons who have received any punishment for any misconduct in disciplinary proceedings while in service are not eligible for consideration

STENOGRAPHER

- 1. Ministerial Officers who retired as L.D. Stenographers or U.D. Stenographers
- Ministerial Officers who retired as on attaining the age of Superannuation and who have not attained the age of sixty nine years
- 3. Ministerial Officers having satisfactory record of service
- 4. Persons who have received any punishment for any misconduct in disciplinary proceedings while in service are not eligible for consideration

ATTENDERS

- The following Last Grade employees who worked in the Subordinate Courts and the High Court are eligible for appointment:
- (a) Last Grade employees who retired on attaining the age of superannuation and who have not attained the age of sixty nine years.
- (b) Last Grade employees who have satisfactory record of service

III. QUALIFICATIONS PRESCRIBED FOR OUTSIDERS:

I. JUNIOR ASSISTANT:

- Must have passed the Bachelors' Degree of any University in India established or incorporated by or under Central Act Ste Act or Provincial Act or an Institution recognized by the University Grants Commission or any equivalent examination
- Must have knowledge or qualification in computer operation

II. STENOGRAPHER:

- Must be a Graduate from any recognized university and must have passed A.P. Govt. technical examination in English Typewriting by Higher grade and must have passed A.P. Govt. Technical examination in English shorthand by higher grade or equivalent examination
- Provided that if candidates who have passed the examination by higher grade are not available, those who have passed the examination by lower grade will be considered.
- Must have knowledge or qualification in computer operation

III. ATTENDERS:

1. Must have passed 7th class examination or its equivalent examination, Candidates who failed Intermediate or its equivalent examination will be considered eligible, but those who have higher qualifications than that will not be considered eligible.

IV. AGE LIMIT FOR THE OUTSIDERS:

Must have completed the age of 18 years and must not have completed the age of 42 years as on 01.01.2023. Age relaxation of 05 (Five) years shall be given in respect of the candidates belonging S.Cs. S.Ts. and B.Cs. Candidates with disabilities and Ex-servicemen shall be given age relaxation of 10 years as per Rules in force.

GENERAL REQUIREMENTS FOR ALL THE APPLICANTS:

- Persons with proven record of ability, good performance and integrity alone will be considered
- Only persons who are of sound health and active habit along will be considered

- 4. Preference shall be given to the local candidates.
