- 1 The applicant must not have completed the age of 65 years, who have retired as members of A.P. Judicial Services.
- 2 Any retired person who held any post in the AP. Judicial Ministerial service or any retired person, who held the post of Assistant, Typist, Examiner, Copyist and above in the A.P.High Court Services is eligible appointment as Court Assistants.

Provided that if suitable retired employee from A.P.Judicial Ministerial Services and AP.High Court Services does not respond to the recruitment notification or otherwise not available, an outsider can be appointed.

3 Any retired person who held the post of Attender, Process Server or in any other post in the last grade services in Subordinate Courts or in the A.P. High Court services is eligible for appointment as Court Attendant.

Who has at least one year to complete 65 years as on the date fixed by the Court in the year of recruitment, shall alone be eligible.

Ministerial service and A.P. High Court service do not respond to the recruitment notification of otherwise not available, an outsider will be appointed and they must have not the age of 42 years and must have completed the age of 18 years as on <u>01.01.2023</u> and age relaxation in respect of SC/ST,BCs is 5 and P.Hs., Ex-servicemen is 10 years as per rules.

The above applicants shall possess qualification of <u>Intermediate or its equivalent examination for the post of Court Assistant and SSC fail or VII pass</u> for the post of court attendant.

DISQUALIFICATIONS:

- Any employee who crossed the age limit of 65 years shall not be eligible for the appointment of court Assistant and Court Attendant.
- 2. Any employee, who has taken voluntary retirement on the ground of Medical invalidation, retired on compulsory retirement from service, Dismissed, or misconduct, shall not be eligible for the appointment of Court Assistant or Court Attendant.
- 3. Persons who have been dismissed or removed from service or compulsorily retired from service or subjected to any other major penalty and misconduct are not eligible to apply.

- 1. The appointments to the post of Court Assistant/Court Attendant shall be for a period of two years and if the work of the persons hold the said post satisfactory, such persons may be considered for appointment for the subsequent period subject to age limit, on the performance of work and on physical fitness of the individuals.
- Preference will be given to the Local candidates i.e., persons living in the same station or near about place and the rule of Reservation need not be followed.
- 3. Preference will be given to those candidates who have experience in the field.
- 4. The Court Assistant/Court Attendant are eligible for 15 days casual leaves for every calendar year and they are not entitled for any other kind of leave. The concerned Spl. Judicial Magistrate of II Class is authorized to sanction casual leave to the Court Assistant/Court Attendant.
- 5. The District Judge is competent to terminate the service of the person working in the posts of court assistant at any time if the work is not satisfactory or there is any physical disability or on the grounds of misconduct or negligence.
- 6. On appointment and while in service a Court Assistant or Court Attendant may be removed without being called upon to show cause if he fails to
