In so far as claiming for SC reservation is concerned, no person who professes a religion different from Hinduism shall be deemed a member of Schedule Caste. However, Scheduled Caste converts to Buddhism deemed to be Scheduled Caste. BCs, SCs, STs& EWS belonging to other States are not entitled for reservation.

PARA-5 LOCAL STATUS

- 5.1 Reservation for Non-local candidates is not applicable as all the posts are reserved for the Local Candidates of the Erstwhile Guntur district only.

Select Post applying for and then select the Caste Category and then click on "PROCEED". Now you'll be shown the online application to enter your complete details. Fill up the details carefully and read the declaration and then click on "SUBMIT".
- 7.5 Once Submitted the online application, you'll be shown the "APPLICATION RECEIPT". Print the application receipt and preserve it for future correspondence.
- 7.6 Applicant can check the details submitted online by clicking on "VIEW YOUR APPLICATION".
- 7.7 If any changes in the submitted application, candidate can go to the "EDIT APPLICATION DETAILS" option provided in Home page. After satisfying the details entered, the applicant can take a print of the online application by clicking "PRINT APPLICATION" and preserve it for future correspondence.

- 8.7 Proficiency Test in Office Automation with usage of Computer and associated Software shall be conducted for the Shortlisted Candidatesfor the post of Junior Assistant/Typist/Junior Steno vide G.O.Ms.No.133, General Administration (Services-D) Department dated: 12.05.2014. The above Proficiency Test is a qualifying test. The Marks obtained in the Proficiency Test shall not be included in calculating the Merit
- 8.8 The appointment of selected candidates will be subject to their being found medically fit in the appropriate medical examination and if he/she is of sound health, active habits and free from any bodily defect orinfirmity.
- 8.9 The details of various stages of the recruitment process, important dates and other information will be posted on the website and the same information will not be shared through any other media. All the candidates should know the relevant updated information by visiting the website frequently.
- 8.10 In case more candidates apply than the number of vacancies mentioned in the notification for the posts for which the basic qualification is "reading and writing in Telugu or English language" as mentioned in para 1.7,the eligible candidates will be selected by conducting a Read & Write Aptitude Test.
