Electronics or equivalent, from a recognized University/deemed University/ Autonomous institutes incorporated by an Act of Parliament of State Legislature in India or UGC Act or from Government approved/recognized institutions.

3. Experience:

The applicant should have minimum working experience of 02 years in Telecom sector, after obtaining the minimum educational qualification, in Government/Public Sector.

4. Age-Limit:

- a) The Maximum age limit is 28 on the date of notification.
- b) Candidates who are serving RailTel Corporation on the last date of submission of application as regular employee or Direct Contractual or outsourced and have put in minimum 03 years service (continuous or in broken spells) as on the last date of submission of applications, shall be eligible for relaxation in upper age limit equal to the length of their work-experience in RailTel/REL, in addition to any other relaxation as applicable.

c) In case of OBC (Non-creamy Layer), the relaxation in upper age-limit is 03 years and in case of SC/ST, the relaxation is upto 05 years.


